Book Exchange

The SCSU Book exchange is modeled on various other take-a-book-leave-a-book programs, such as grassroots community pop-up libraries. The program also offers first years receive one free textbook by showing their syllabus. The goal of this program is to help students with the high cost of textbooks, and other academic books by promoting the sharing of these books. During this semester, we are piloting weekly exchanges, Thursdays 12-2pm outside the SCSU

Office (SL 108) so that students have an increased ability to access the Exchange, but also so that the Exchange is able to be better known among students.

Food Program

The SCSU has currently been doing a monthly pop up food bank as the permanent food bank is set up. The SCSU has submitted an application with Daily Bread to receive food items (perishable and non perishable), and our application has been processed. We are currently hiring a food program coordinator, so the food bank can start in March.

KFC Menu Boards

KFC Menu boards have been updated with calorie counts to fulfill the Healthy Menu Choices Act.

Microwaves

We are currently having conversations with the university regarding how many new microwaves can be put in, to ensure proper space and voltage.

Rex's Den

A select few menu items have increased in price due to it being too cheap to support labour costs. A late night menu has rolled out for Tuesday to Thursday from 8-10pm. The late night menu allows Rex's Den to lower labour costs, due to the lack of traffic during those time periods.

Student Centre Washroom

Second Floor washroom was temporarily closed for parts of December and January to repair washrooms. The washrooms are now open again, but the foot washing station is still out of use. Parts for the food washing station will have to be custom ordered, and will be repaired as soon as possible.

Tax Clinic

The Tax Clinic is a service that helps UTSC students to file their personal income taxes and learn how to do it as well. The Tax Clinic Coordinator Nirusaa Nirmalananthan has been hired, as well as the Tax Clinic Senior Associates. We are currently hiring the Jr. Tax Clinic Associates. WHEREAS international students have been removed from Ontario Health Insurance Plan since 1994, and have since been integrated into costly private health insurance

programs like the University Health Insurance Plan, and;

WHEREAS even in a densely populated city like Toronto, international students are discouraged from seeking medical assistance because of the difficulty around finding doctors, clinics and specialists who accept the use of UHIP and CHIP, and;

WHEREAS other provinces like Manitoba, British Columbia and Nova Scotia all cover international students under public health insurance, and;

WHEREAS all students across Ontario deserve a right to affordable and accessible health coverage and healthcare, regardless of their citizenship status.

SCSU had also provided self-care packages for attendees recognizing self-care is very important especially in the settings.

Members of SCSU who attended the Annual General Meeting passed a motion whose resolution was that the SCSU donate money to a Haitian-led organization of Caribbean Connections' (CC) choosing. This motion was put forth in response to the lack of responsiveness post-Hurricane Matthew on the part of the government, the media, and other institutions. Another aspect of the motion included supporting CC's "Hope for Haiti" campaign. Just last week, the President met with Caribbean Connection executives to see which organization they've decided we must donate to, which they have decided would be Sakala. This organization guarantees a tracking system for those who choose to donate in order to ensure transparency. We also discussed how CC intends to roll out their campaign, and how SCSU can act as a resource and as support. Please expect a follow-up once the donation has been made.

Kirk speaks on **Provost's Undergraduate Student Advisory Group** On the 6th of December, the President was asked to meet with various student societies and student unions across UofT with the Vice Provost, Students. We addressed our disproval of Jordan Peterson being given platforms to inflict further violence on trans students, non-binary students, and Black students. We were all updated on the status of the governance process for the Sexual Violence Policy, along with temporary location of the Sexual Violence Prevention & Support Centre at the St. George Campus. Its location will be on the 6th floor of iSchool at the Claude T. Bissell building, room 605.

Kirk recommended that Warsame encourages students to run to be part of the Board so that IDS students can be represented by the Board.
