Education For All

As part of the Education For All Campaign, the VP AUA has been working with the SCSU team to create a social media campaign that highlights the student voice. Through a number of social media posts and stories, each Education For All demand was represented by a student and executive testimonial that expressed the urgent need for a more accessible education at UTSC. During the SCSU Week of Welcome, the VP AUA hosted a direct action for students to get involved in the campaign. Through simple steps like using mailing tools and phone banking, students came together to organize around the call to action. The email tool remains on SCSU's website, consisting of a letter that the executives have written, addressed to the University of Toronto administration. During the fall semester, the VP AUA hosted 2 panels as part of the Education For All Webinar Series, focusing on the experiences of Black Learners and those living with a disability. On January 19th, the VP AUA continued this series, hosting a panel to highlight the experiences and stories of Indigenous learners across Canada. This panel highlights the different colonial powers embedded in our education systems, and how we can work together to dismantle systems of oppression. The VP AUA, along with the other executives, has been actively working on a lobby document to present to the administration. This document will outline the pressing need for an accessible education, along with highlighting the ever-changing circumstances that students are in during the COVID climate. Free Book Network

The Free Book Network is one of SCSU's five service centres. This service aims to provide students with academic resources by subsidizing the cost of textbooks, subscriptions and software that students will be using in their academic journey.

The Free Book Network launched its service availability on January 20th, partnering with the UTSC Library to host an info session on the operations and logistics of the Free Book Network, along with online resources that are available at the UTSC Library. From e-reserves to open textbook sources, the VP AUA and Free Book Network Coordinator discussed alternatives to the Free Book Network and how students can access the course materials they need. With the need for digital access continuing to grow, the SCSU Free Book Network will stand as a service centre to help students with the digital tools they need. With the support of the Free Book Network Coordinator, this service centre will be introducing a laptop program to support students with remote learning and support them in their journey to academic success.
