# D. CRO Report

SS: Our methods were consistent with the previous SCSU elections held. We were able to hold to the Elections Forum on March 19<sup>th</sup>, where each candidate was able to speak individually to the students. There was an Election Day discrepancy between the voting list and the students eligible to vote. Though, many eligible voters were not included in the voting list, the elections committee was still able to hold a fair election. Initially, DSL gave us a student list that contained first and last names, when we followed up the next time, they gave us a list that was still missing pertinent information that was necessary in order to determine the eligibility of potential voters. Polling clerks were told that if names were not on the list than they would have to present their ROSI account to the polling clerks.

SS: Recommendations: Pay close attention and verify that the student voter e-copy list is the exact duplicate of the student voter hardcopy list which is presented to the elections team. Also pay specific attention when printing out the hardcopy voter lists to ensure that it matches all corresponding e-copy lists particularly first year students. Also the DSL must ensure that the total number of student enrollments during the school year matches the total number of student's names present within the voter list which is presented to the elections committee.

FR: In some instances, some of the poll clerks did not monitor the voters appropriately, as on the first day of voting, the lists were not properly provided. In recording this discrepancy, I sent an email to PT, GA, and HM.

AA: What exactly were the issues that you found with the lists provided?

SS: This is a recurring problem that has not only happened in this election, but in several elections prior. I would suggest that the SCSU work with administration closer in order to provide the accurate lists necessary that would be conducive to hosting a proper election.

II: If you had problems with the lists, did you tell anyone?

SS: According to Elections Committee bylaws, we are not supposed to discuss any issues with any other individual except for PT. I would like to reiterate that either the CRO or DRO is always there.

RR: Why did the electoral procedure still continue if the right information isn't there?

ZM: I think we need to pay the Elections Committee, appoint the winners of the election as they stand now, and have another election in September.

HJ: The reality is that we are all here not because we can follow a simple piece of paper, but in reality we all have independent minds that we can use.

AA: Even if we are to go through a new hiring process, our VP HR is gone. We also need more resources in order to do this properly. It's going to be hard to integrate people into the SCSU if we have the election in the Fall. Also, the majority of the election was voted properly. Although, there was an issue, we should be pointing fingers at the DSL.

RR: I agree with AA, our goal should be how to resolve the issue and not to blame DSL.
